Candidate Conduct Policy

Candidates taking CWNP exams must agree that they have read and will abide by the terms and conditions of the CWNP Confidentiality Agreement before beginning such examination. Under the terms of the CWNP Confidentiality Agreement, each candidate is required to agree to be bound by its terms and conditions. No candidate will take any action that will compromise the integrity or confidentiality of a CWNP Certification examination or otherwise compromise the integrity of the CWNP Program. Such actions include but are not limited to:

- Disclosing, publishing, reproducing, transmitting, or accessing any exam and any related information including, without limitation, questions, answers, worksheets, computations, drawings, diagrams, length or number of exam segments or questions, or any communication, including oral communication regarding or related to the exam, in whole or in part, in any form or by any means, oral or written, electronic or mechanical, for any purpose, without the prior express written permission of CWNP.
- The access and use of “brain dumps” for the purpose use of increasing a candidate’s score is prohibited. The methods by which CWNP, with the help of Prometric and VUE, determine if “brain dumps” are being used by examinees are not released.
- Use of falsified or altered Certificates, Score Reports, or other documents or electronic media used to misrepresent the Certification status of a candidate.
- Using any aids, notes, equipment or other materials not authorized by the Testing Delivery Partners or CWNP during the exam.
- Providing falsified documentation as a means of a false identity, false address or solicitation of someone to take a test on another’s behalf.
- Failure to protect Certification content including labs through carelessness or in an attempt to shield facts regarding a violation.
- Causing a disturbance of any kind in a testing facility; removing or attempting to remove questions and/or responses (in any format) or notes, note board, or scratch paper from the testing room.
- Tampering with the operation of the testing facility computer or attempting to use it for any function other than taking a CWNP certification examination during such examination.

Notice of Violations and Sanctions

If it is determined that any candidate has violated the Candidate Conduct Policy, CWNP will send such candidate a written notice of violations and applicable sanctions. It will be the Certification candidate's sole responsibility to ensure that CWNP has a current address and email address for the Certification candidate.

Remedies for Violating the Candidate Conduct Policy

Any candidate determined by CWNP to have violated the Candidate Conduct Policy shall, if determined necessary or appropriate by CWNP based upon the seriousness of the incident or violation, be made ineligible to register and/or schedule any CWNP examination up to including a lifetime ban and voiding of all previous certifications from the date of such determination.
